How IFS Cloud supports production-line risk management

Centralised risk visibility across operations

- The Risk Register within IFS Projects and Document Management provides a structured way to capture and track risks.
- Risks can be linked directly to production structures such as Production Lines, Work Centres, Manufacturing Routes, Operations and Equipment.
- Users can attach documents, procedures, inspection results and maintenance history to each risk record for complete traceability.

Consistent assessment and scoring

- IFS Cloud supports configurable likelihood, consequence and detection scoring models, often used alongside FMEA/FMECA methods.
- Scoring within Quality Management and Equipment Reliability helps teams prioritise risks affecting product quality, safety, or uptime.

Integrated mitigation planning

- From the risk record, users can create actions such as Corrective and Preventive Actions (CAPA), Engineering Changes, Maintenance Tasks, Training Activities and Supplier Follow-ups.
- CAPA workflows in the Quality module ensure accountable owners, defined timelines and verification steps.
- Maintenance actions flow into Preventive Maintenance Plans, Work Orders and Condition-Based Maintenance schedules.



Real-time monitoring and early warnings

- Shop Floor Execution and Production Reporting provide real-time feedback on deviations, scrap, delays and machine utilisation.
- Integrated sensors, IoT feeds and Condition Monitoring tools can highlight temperature, vibration or pressure anomalies that increase operational risk.
- Alerts and workflows triggered through IFS Lobby dashboards, Event Actions and Notifications ensure rapid response.

Quality assurance and compliance links

- Non-conformance reports, quality inspections and batch traceability within IFS Quality Management feed directly into updated risk assessments.
- This supports ISO and industry compliance, providing auditable evidence of how risks are controlled.

Equipment and asset risk control

- Enterprise Asset Management links equipment performance, reliability and past failures with the risk register.
- Maintenance teams can analyse failure modes, identify high-risk assets and refine maintenance strategies such as Predictive and Condition-Based Maintenance.

Supplier and material risk visibility

- Supply Chain capabilities track supplier performance, delivery reliability, material availability and quality issues.
- Supplier risk can be connected to production-line risks, helping manufacturers avoid stoppages caused by late, non-conforming or inconsistent supply.

Continuous improvement and learning

- Insights from production KPIs, OEE, downtime analysis, inspection results and maintenance findings feed continual improvements to risk scoring.
- Manufacturers can refine standard operating procedures, update training, or adjust planning models to avoid repeated issues.
